Dear Member,

The BMPA, as you may already know, is celebrating its 60th aka Diamond Anniversary (1954-2014). The Managing Committee has planned a handful of events and programmes to mark this momentous event between March 2014 to Dec 2014. In Jan 2015 we will draw the curtain on this almost year-long celebration over Print Summit 2015.

Earlier in March we undertook, the first-of-its-kind, exclusive study tour to Germany in cooperation with Heidelberg India (HIN), Heidelberger Druckmaschinen (HDM), IST Metz and Polar Mohr.

Presently, we have a goal to contribute towards **1,000 medical checkups for the staff of our group members**. To help realize this project we have **tied-up with MED-IND Concepts** (MIC) who are empanelled and certified to issue Fitness Certificate under the Factory Act.

The Factory Act makes it mandatory and binding on all factory owners to undertake periodic, yearly, medical fitness examination of their "shop floor" workers as per provisions legislated in the Act. Violation of this requirement leads to extreme situations and will also affect the health of your business. So let's act legitimately and be a 'healthy' business.

The BMPA-MIC programme includes investigations and consultation: 1. Complete Physical examination: A. **Surgical Check-up** B. Medical Check-up C. **Dermatological Check-up** Now to be held between Vision D. June 23rd to 26th at Meeting Room, Terrace, 2. Blood Tests: A1 - Shah & Nahar **Industrial Estate, Lower** A. **Blood Group** Parel. Read through B. **Complete Hemogram** pages 1 to 3 and register C. **Blood Sugar (Random)** asap. S. Cholesterol (40+) D. 3. Urine Examination 4. Electrocardiogram (40+) 5. Pulmonary Function test (computerized)

#### **Report Details**

- All reports within 15 days and post check up consultation will be conducted for the employees with abnormal reports.

- Laminated Photo cards.
- Database CD
- Form No. 7 (fitness certificate) as per the Factory Act

# How does this programme work?

- 1. You have to fix an appointment for your staff within the given sets of date ranges in this letter.
- 2. For booking an appointment you must contact the BMPA via email or letter.
- 3. In the email/letter please specify the date of your choice. The date schedule is published on page 3. You will be required to provide us a list of the total shop-floor/factory staff you wish to enroll for this programme. For enlisting you must provide us a list (in excel format via email to us at <admin@bmpa.org>). The list should contain the full name, birth date, gender, department + designation and contact number respectively of every shop-floor/factory employee. Along with the above you must also send us a payment vide **Pay-Order** in favour of "MED-IND Concepts" must also be included, as per costing shown herein-below, with your letter. We require you to appoint a contact person within your team/press/office who will be the one-point contact with us (and MIC) for this programme.
- 4. The BMPA will then contact you to confirm your appointment and share any additional/specific requirement. We will write to you and also send out an email acknowledging all of the above.
- 5. The MIC facility will be able to handle no more than 150 people on a given date. If the date you select is committed/booked/already-taken then you need to make another selection. Appointment date will be provided on first-come basis provided all conditions as per point (2 and 3) are completely fulfilled viz. Intimation of date preference, the list and requisite payment.
- 6. On the appointed date: Your staff/workers will need to visit MIC's facilities in Thane (as per address herein) on the pre-selected date along with a duly endorsed confirmation from the BMPA as covered in point (4) above.
- 7. An appointment once made must not be cancelled. Any no-show by enlisted personnel for the appointment will lead to forfeiture of fees. However, MIC at its sole discretion will evaluate such cases individually and may under select and exceptional reasons provide an alternate date and venue for the respective testing. There will be no refund issued under any circumstance except where proof of deficiency in services is being established.
- 8. Payments: You will be charged a sum of Rs.350/- per personnel investigated. The BMPA will bear the charge associated with the first two investigations from your company. These two investigations will be complimentary for you on occasion of the BMPA's 60th year celebrations. For the balance remaining numbers you must issue a Pay Order in favour of "MED-IND Concepts" as stated above. For eg: If your shop-

floor/factory employee strength is 20 then you will pay for 18 @ Rs.350/- The expense for the first two will be issued by the BMPA to MIC directly.

9. All investigation reports under this programme will be sent to the BMPA's office by MIC and in turn the BMPA will forward them to respective members.

There are three unique sets of date-range for June 2014. You must select any one day and date from within the date range as per below.

- 1) 09/06/2014 to 12/06/2014 (9.30am 1pm and 2pm to 5pm Monday through Thursday)
- 2) 16/06/2014 to 19/06/2014 (9.30 am 1pm and 2pm to 5pm Monday through Thursday)
- 3)\*23/06/2014 to 26/06/2014 (9.30 am 1pm and 2pm to 5pm Monday through Thursday)

## Testing at your door-step

If your press facilities or industrial estate building can provide a dedicated room of atleast 30X30 sq feet, 3 tables, 9 chairs, and 5 electrical points then we could arrange to get MED-IND Concepts to set-up a make-shift testing facility in such an area for a particular date/s. However, please note that the minimum number of personnel required per day is 50 and max 150. The fees will remain the same and the date/s for such testing will be different from those confirmed above. Please contact us separately for this facility via email/letter along with the list as required under point 3 and payment as per point 8.

We look forward to members deriving maximum advantage from this scheme and getting compliant with the needs of the Factory Act on a periodic basis.
