Information On Membership And Method Of Acceptance

BMPA presently provides membership to businesses under following category:

MEMBER

Business engaged in the Printing / Converting owning an operative plant or, manufacturing unit or office with a resident director as domicile and situated in Mumbai Metropolitan Region (MMR) under the geographical territory of Mumbai Metropolitan Region Development Authority (MMRDA).

INVITEE GROUP PRINTER (IGP) MEMBER

Business engaged in the Printing / Converting owning an operative plant or, manufacturing unit and situated in regions outside of MMR but within India.

INVITEE MEMBER

Business from a related industry who sympathizes with the aims and objects of the Association and/or desires to participate in any of the activities of the Association with stake in Printing Industry wherein it is directly or indirectly related in supply, manufacture, trade, service, support of goods/services that can be broadly termed as inputs or allied inputs or ancillary supplies or support for purpose of printing / converting.

INTERNATIONAL MEMBER

Business headquartered or operating from overseas that is either engaged in Printing / Converting or qualifying under Invitee category that is principally perceived to be as located or operating from outside of India.

Procedure and Fees for Membership

1. Membership applications are scrutinized for eligibility by Managing Committee (MC) at its monthly meeting.
2. The membership / admission fees are debited only after membership approval by MC.
3. The Fees are based on Category of Membership, while the admission fee is a one time fee payable-upon entrance or upon rejoining, the annual fee is payable and due on commencement of every fiscal.
4. Membership accruing in second half of financial (Oct-Mar) will be charged 50% of Annual Subscription plus GST as applicable
5. In the event of an application is rejected, read clause as per point no 2 above.
