LEAGUE RULES & REGULATIONS

DOUBLES TOURNAMENT ONLY

SCORING SYSTEM

- ◆ A match consists of one game of 21 points except Semi-final & Final will be best of 3 games of 15 Points.
- ◆ Every time there is a serve there is a point scored.
- ♦ The side winning a rally adds a point to its score.
- ◆ At 20 all, the side which gains a 2 point lead first, wins that game.
- ◆ At 24 all, the side scoring the 25th point, wins that game.

INTERVAL AND CHANGE OF ENDS

- ♦ When the leading score reaches 11 points, players will change the end.
- A2 minute interval between each game is allowed.

DOUBLES

- ♦ A side has only one 'service'.
- ♦ The service passes consecutively to the players as shown in the diagram.
- ◆ At the beginning of the game and when the score is even, the server serves from the right service court. When it is odd, the server serves from the left court.
- ◆ If the serving side wins a rally, the serving side scores a point and the same server serves again from the alternate service court.
- If the receiving side wins a rally, the receiving side scores a point. The receiving side becomes the new serving side.
- The players do not change their respective service courts until they win a point when their side is serving.

LEAGUE RULES & REGULATIONS

In a doubles match between A & B against C & D. A & B won the toss and decided to serve. Ato serve to C. A shall be the initial server while C shall be the initial receiver.

NOTE THAT THIS MEANS:

- ◆ The service court is changed by the servicing side only when a point is scored. In all other cases, the players continue to stay in their respective service court from where they played the previous rally. This guarantees an alternate server.
- ♦ Although adequate safety precautions have been taken and medical facilities will be available to treat any injuries sustained while playing, we will not be held responsible and liable for the same and the players will be playing at their own risk.
